## Florida Gold Coast Figure Skating Club Testing Policy

- All applications for testing must be made in writing on the official FGCFSC test application form.
- Applications are considered incomplete and **tests will not be scheduled** for the following reasons:
  - Missing USFS #
  - Illegible information
  - Incorrect or missing test fees
  - Skater's USFS membership not current
  - Missing coach's signature
  - Missing out-of-club permission form
  - Coach is missing required USFS credentials
  - Any missing signatures or information where indicated including the attached waiver, agreement, and consent forms
- The deadline for submitting completed application forms and all required test fees is 5:00 PM ten (10) days prior to the scheduled test date. Application forms may be dropped in the locked club box outside the coaches' room, hand delivered to a club officer or the test chair, or mailed to the address listed on the test form. If mailing, please allow sufficient time for delivery, as the application must be in the hands of the test chair by the deadline. No faxed or emailed applications will be accepted.
- Applications submitted after the deadline will only be accepted at the discretion of the test chair, space permitting, and **require a \$25 LATE FEE payment before being allowed to test.**
- Test fees may be paid by cash, check, or money order made out to FGCFSC. If a check is returned, or insufficiently funded, all amounts owed, including bank/NSF fees, will be immediately due.
- **No Refunds or credits** will be given for tests cancelled by a skater or coach once the deadline for entry has passed, unless the CLUB cancels the test session. **No Refunds or credits** will be given if a skater or coach fails to appear or is unprepared for a scheduled test. If a skater is not ready for a test, DO NOT submit the test application. Test fees may only be refunded or credited after the deadline for extraordinary circumstances and upon majority vote of the Board of the FGCFSC.
- If a panel of judges is not the appropriate level for a particular test, a skater may request postponement until the next test session that the appropriate level judges are available or request a cancellation and return of the test fees.

- The test chair has the right to change test session dates and/or times. The test chair also has the right to cancel an entire scheduled test session or an individual test for reasons including, but not limited to: 1) unavailability of appropriate judges, 2) lack of sufficient test applications, or 3) the test session runs overtime. In these cases the skater may be given a slot at the next test session or the test fees will be refunded to the skater.
- Skaters must first pass the appropriate moves in the field test before taking the corresponding free skate test. When applying for both the moves in the field and the corresponding free skate test, the **TOTAL FEE FOR BOTH TESTS** must be included in the test fees with the test application. If the skater does not pass the moves in the field test, the fee for the corresponding free skate test is **FORFEITED**.
- All applications will be prioritized according to the date received and will be accepted until the deadline or until the test session is full. See above stipulations regarding applications submitted after the deadline, including the mandatory \$25 LATE FEE.
- The test schedule will be posted at the rink no later than two (2) days prior to the scheduled test date. Additionally, all out-of-club skaters will receive an email to the address provided on the application with the test schedule and any specific instructions no later than two (2) days prior to the scheduled test date.
- Test schedules are approximate and tentative as test sessions frequently do not follow the exact time structure scheduled. All skaters **must arrive one hour prior to the skater's warm up time** and should be prepared to test up to one hour before their scheduled time. If a test session runs early and a skater is not present or not prepared to test, the skater **forfeits all fees** for that test.
- Remember to always thank your judges. They are volunteers and are sacrificing their time and skill for our benefit. The best time to thank the judges is before you leave the ice. A quick wave, curtsy or smile, along with a verbal "thank you" will go a long a long way in making the judges feel the appreciation they deserve.

("AGREEMENT")**

In consideration of participating in FLORIDA GOLD COAST FIGURE SKATING CLUB activities, I represent that I understand the nature of figure skating activities ("activity") and that I am qualified, in good health and in proper physical condition to participate in such "activity". I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the "activity".

I fully understand that this "activity" involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the "activity", the conditions in which the "activity" takes place, or the negligence of the "Releasees" named below; and that there may be other risks either known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the "activity".

I hereby release, discharge, and covenant not to sue the FLORIDA GOLD COAST FIGURE SKATING CLUB, United States Figure Skating, it's directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the "activity" takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

The FLORIDA GOLD COAST FIGURE SKATING CLUB has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the FLORIDA GOLD COAST FIGURE SKATING CLUB shall not be responsible for the supervision of members and other non-member participants on the Ice.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
